Foreword

As we unlearn to reconcile with journey of life every day, we have learned more how to navigate through an unusual journey called pandemic. Adversities have taught us to invent ways and means to continue living with usual demeanor, and have made us resilient to respond to the crises again and again.

The saddening memory fills our heart with remorse and helplessness for precious life lost to Covid-19. During such moment, we could realize that we are held together by a strong humanitarian bond, which helped us overcome collective grief; it gave us strength to remain hopeful, even after seeing the nation at door step of an impending peril.

The year has seen a phenomenal rise in the tragedies of the common. Return of the migrant workers to their villages, people covering hundreds of miles on foot to reach home, loss of employment, unyielding miseries, and inequality in alien and fearful form.

Pandemic has curtailed scope of interacting with people directly. Remaining strictly within the COVID norm, project staffs endured hassles of lock down and shut down to implement the activities, ignoring their pressing need at domestic and personal front. Fulfilling the mandate of empowering the slum dwellers required intensive physical interaction, which was quite unfeasible during the covid-19 surge, but were achieved in most uncompromising manner.

Social facilitation had been instrumental in forging deep ties with the community, understanding their need, helping them overcome difficulties of daily life. Connecting them with the regular process of empowerment was possible because of committed effort of the project resources, as they had had remained constantly with communities all throughout the period. When fear of covid was looming at large, we took the help of technology to reach to the community members.

Human right violations are deep and insidious, they happen in all societies across the world, in different proportions. When governance becomes participatory through democratic institutions, as envisaged, administrative control may turn people centric, and HRVs may gradually reduce. We took the onus of striking balance between the emerging issues of HRVs and responses of the government machineries and democratic institutions. We had persevered to bring to the public domain such happenings which could possibly lead to delivery of justice or bring the desired flexibility in the system, in-order to respond to the need of structural change in future.

I have the pleasure in bringing Annual report 2020-21 to its present form. The report presents a brief overview of the activities implemented, its result and its outcomes.

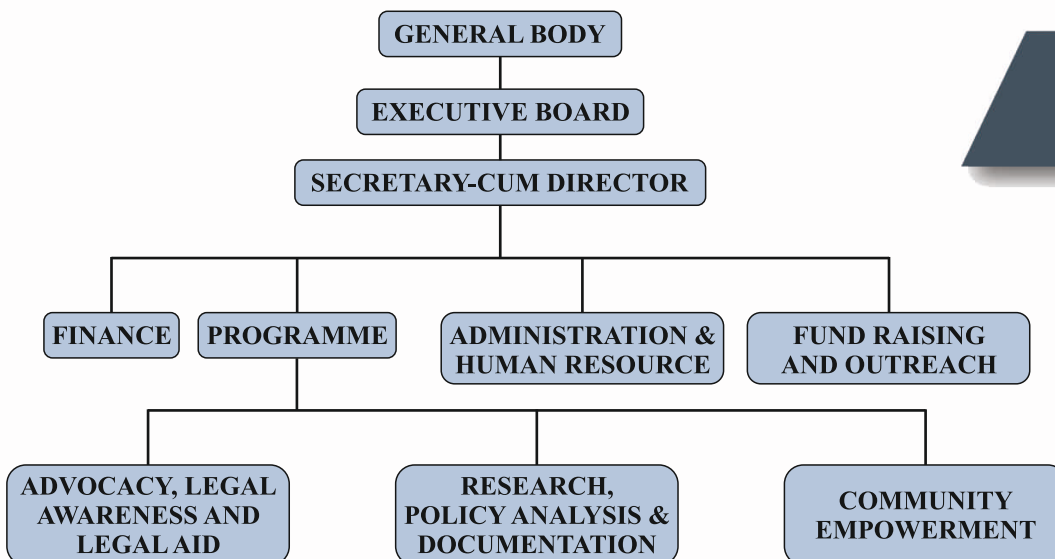

Social Facilitation Centre:

Two Community Institutions (Social Facilitation Centres - SFCs) have been established and operational in two slums namely, one at Shikharchandi Nagar and another at Pandakudia in Bhubaneswar city. Two SFCs are functioning well and taking up slum-dwellers problems also. Two human rights defender-cum-Community Facilitators with relevant experience and knowledge have been deployed at the Centres. Services have been rendered to 1828 helpless and marginalized people who have visited the centers with their problems.

PROGRAMS

Awareness and Capacity Building Programmes

Training program on Un-organized Labor Rights: Training programs were organized by CSNR in different slum of Bhubaneswar. Forty-five (45) participants participated in the programs. The objective of the training program was to make the leaders, volunteers and unorganized labor aware about the welfare schemes for unorganized labour.

Health awareness programs

Education Awareness Training Programme:

Education awareness training programme was organized by CSNR at three places (JalimundaSahi, Sikharchandi Nagar and Pandakudia) in project slums of Bhubaneswar. There were 76 participants participated in the three programmes. The community leaders, volunteers, parents and others were made aware on the rights to education of a child starting from the age 3 to 14 years. They were made aware relating to Travel/ Escort Allowances, EWS reservation in private schools and other.

Health Awareness & Orientation Programme: Health awareness training programmes were organized by CSNR in slum of Bhubaneswar. More than 50 participants participated in the programs. The slum dwellers were aware of their health rights and the different government schemes related to health rights.

Human Rights Awareness Program at Sikharchandi & Pandakudia Slum: The program was organized in two slums with the purpose to prepare the people on their rights and entitlements. The program was held on 5th Dec 2020 at Sikharchandi Nagar & on 7th Dec at Pandakudia. About 173 individuals (Sikharchandi - 100 & Pandakudia - 73) attended the event. Slum leaders, school teachers, children of that slums, and staff of CSNR attended the program. In Sikharchandi Nagar Slum, the children participated and an extempore speech competition was organized between them, they also performed solo dances and group dances. In Pandakudia, along with dance, the children enacted a play by taking six fundamental rights as theme of the play.

Awareness training on Urban Housing Scheme: Two numbers of awareness training programs on urban housing were organized by CSNR. One was organized at the CSNR office through which the staffs were enriched with the knowledge of urban housing schemes. The other was organized at Sikharchandi Nagar, the project slum. There were 47 participants and they were made aware about the different housing schemes of the government.

Sishu Sampark Jatra:

The program was held on 19th February 2021 at Sikharchandi Nagar, it was organized by Odisha State Commission for Protection of Child Rights, and supported by CSNR, CCWD & other committees of Sikharchandi Nagar community. Apart from officials from OSCPCR, around 70 individual participated in the program. Ms. Sandhyabati Pradhan, Chairperson, OSCPCR, Dibya Sawati, Member OSCPCR, Banishree Pattnaik, DCPO khordha, ASWO, CDPO, Anganwadi workers, Childline, School HMs, Members of CSNR, CCWD's & ActionAid, Sikharchandi Community representatives & members, Pandakudia slum members and other delegates participated in the program. The objective of the program was to review the status of health, education & mental well-being of the children in the state. Ms. Sandybati Pradhan Chairperson, OSCPCR shared her concern on child right violations during the pandemic situations. "Sishu Samparka Jatra" has been underway since January 20 this year. Authorities are aware of child helpline number (1098). Child rights violations could be stopped and even could be eliminated if timely actions are taken. Problem faced by children during and after Covid was discussed. Children were interacted, after which a cultural program was held.

The cases heard by the chairperson are.

- ▲ Denial of admission to the school due to lack of aadhar card.
- ▲ Children being neglected because they do not have a mother & care taker.
- ▲ Negligence of children suffering from disability
- ▲ After the displacement of their habitat, the children are faced with difficulties, how to manage the expenses of traveling to new schools, which are far away from their new locations.

Workshop on Access of Children of Urban poor to Free & Compulsory Education-A workshop was organised relating to Rights to Education of slum-dweller children on dated 16th Dec, 2020 at Red Cross Bhawan, Bhubaneswar. School Principals/Teachers, Experts, Educationists, Community Organisers/Volunteers, Communities leaders, civil society members, Journalists, child rights activists were a part of the workshop. The purpose of the Workshop were (1)analyse issues related to non-admission of eligible children in government schools and drop-outs, (2) identify structural and policy issues,(3) bring-out/highlight slum issues before larger society, (4) facilitate dialogues among community leaders with duty bearers and (5) build up follow up strategies. There were 40 participants in the meeting. A follow-up strategy was prepared to move forward. A memorandum was signed by the participants and submitted with the authorities.

Committee for conservation and management of community forest resource (CFR) management was constituted in 12 districts with active facilitation and support of Gram Sabhas. CSNR could ensure this regular orientation and training through its district campaign network. The CFRMC constituted are as follows, Baragarh 20, Sundargarh 17, Rayagada 16, Balangir 12, Ganjam 18, Malkanagiri 6, Kandhamal 4, Gajapati 2, Nuapada 4.

Workshop on land & housing right of the slum dwellers: A workshop was held on 24th Feb, 2021 at Red Cross Bhawan, Bhubaneswar. The objective of the workshop was to assess the challenges faced by the slum dwellers, on issues such as housing & land rights. The workshop also aimed at analyzing gaps at policy levels & to develop strategic action plans for addressing such problems.

Comprehensive report that was prepared was shared during the workshop. The workshop resulted in unanimous and indicative suggestions for building efficacies of the housing mission by the Government by ensuring allocation of houses to the registered families as per the RAY norms and including the left out slum dwellers in RAY. Further Government should also provide legal title of the land and house to the right holders. Land encroachment by the city dwellers and corporate are a menacing reality this days, which needs to be prevented. Sources of Livelihood in the slums are still fragmented and unsustainable. Government should build scope for people to generate income within their habitation. Scope in this direction is needed to prevent distress during difficult times. Migration of people from rural areas to city is also due to their landlessness in their native. Ensuring right of lands in rural areas to control migration of rural people to the cities is essential. Corporates should be kept away from sharing of land, BDA and Odisha Housing board Corporation should take care of all sharing of land matter.

Public Hearing on Food and Nutritional Security of the slum Dwellers: A public hearing was organised on Food and Nutritional Security of Slum Dwellers on 29th Dec, 2020 at Red Cross Bhavan, Bhubaneswar. Ten numbers of affected community and their defenders/advocates presented their cases before civil society and the decision makers for improvements in their situation. Twenty community organizers/volunteers/leaders were aware of their rights to food and nutritional security. Eminent Food Rights and Health Rights activists, former Judge, Bureaucrat and Journalist were members of Jury Panel. They cross-checked the cases presented and intensively enquired from the affected persons and witnesses and presented their Observation Report before Media and Civil Society. A Memorandum was drafted and signed by the participants and submitted with the Food Rights Commission and the Secretary, Department of Food Supplies, Government of Odisha

Leadership Development Trainings:

Two Regional Level "Leadership Development" training was conducted in south and West zone. First regional training was held in South zone on 17, 18 and 19 Dec. 2020 at Parlakhemundi, Gajapati with participants coming from Malkanagiri, Gajapati, Ganjam, Rayagada and Kandhamal. Three days training was held for youth leaders on "Rights to Information", Understanding Forests & Forest Rights of the Forest Dwellers, Legal Provisions and Process of Claim Making, Network Building were the key agenda in the programme. More than 32 individuals including 12 female have participated in the three days programme.

Participatory Learning Workshop for Human Rights Defenders on Minority Rights & Freedom of Religion - Accessing Rights & Entitlements- A two day workshop was organized at Maha Buddhist Society on dated 22nd and 23rd of March, 2021 in collaboration with minority Rights International. On the second day of the training a tribute was given to Bhagat Singh. There were more than 50 participants from different corners of Odisha

▶ Regional Level Training:

Second Regional Level training was organized in West zone at Paikamal, Baragarh on 29, 30 and 31 Dec. 2020 inviting youth leaders from Balangir, Baragarh, Dhenkanal, Keonjhar, Nuapada, Mayurbhanj and Ganjam districts. Total no of 32 participants participated in the programme. Training was on RTI and how RTI can be used in getting justice and redress grievances. The process on how to apply for information, process of appeal in detail besides how to fill forms to seek information from various authorities was demonstrated. FRA its provisions and procedures for recognition of forest rights, process of claim filing was also discussed.

▶ Community Capacity Building Training on Forest Rights Act:

District Level Community Capacity Building Training on FRA was organized in all the 11 districts. Two days capacity building training conducted in each districts as held with participation of community leaders, educated youths and members of forest rights committees. The campaign has managed to cover district level capacity building training adhering Covid19 guidelines. Emphasis was made on livelihood promotion through convergence with IFR land for agriculture and horticulture, vegetable cultivation under MO Bagicha and other government programmes to mitigate the food insecurity. The participants were also oriented to carryout plantation of traditional species within CFRs, as a process of rights, assertion and ownership.

▶ Women leadership training:

Women leadership training was organized in Malkanagiri, Rayagada, Ganjam, Kandhamal, Balangir and Sundargarh, and Keonjhar districts. Contribution and participation of women in cover response activities has been very impressive and successful. Women empowerment training and leadership development in Rayagada, Keonjhar and Kandhamal and engaged them much in the forest conservation activities. The role of women in managing the Covid19 crisis was significant and praiseworthy.

Training on preparation of CFR Management Plan:

Training on preparation of CFR Management Plan was organized in the villages of 10 districts. Several meetings have been conducted in the villages in all the locations on preparation of management plan. The process of preparation of CFR management plan has already been started. Interaction of our network facilitators with officials and government department during Corona crisis was very encouraging.

Orientation and training to community volunteers:

An orientation and capacity building training programmes was imparted to the community leaders/ volunteers along with the community organizers on dated 25th March, 2021 at Maha Bodhi Society (Buddha Mandira). There were 40 participants in the training programme. They were empowered to access their rights and entitlements and to take part in decision making process.

Capacity Building on Project Management, Governance, Organisational Development, Institutional Leadership and Skill development:

A three days training program on governance and skill development was organized on dated 29th to 31st March, 2021 at THREAD, Jatni. The participants were mainly CSNR staffs. There were 11 participants and they were facilitated to learn on concepts of Project Management, Governance, Organisational Development and Institutional Leadership and they were oriented on how to link with community empowerment and human rights advocacy activities.

Use of Digital Media for Problem Redress:

Training and Capacity building program was organized on "Use of Digital Media for Problem Redress" for 13 community youths of 7 villages at village Janibil, Beguniapada, Ganjam District on dated 27 Nov. 2020. During the training, youth were oriented for positive use of digital medium and mobile phones for recording and documenting information on the problems and share them with the government authority through WhatsApp, Twitter and other social media platforms. Learnings of this training made a successful impact on addressing the long delayed problems of drinking water problems of Baidipada villagers and made the administration alert & responsive. A video record was made on defunct solar system (motor), used for pumping out water in the village. Several complaints for repairing were made but there was no response from the officials/authority. The video was shared with District Collector, who promptly directed BDO Beguniapada for necessary action and also communicated to Gram Panchayat. Next day, solar pump was repaired and drinking water issue was resolved. This created a positive impact, as the Panchayat officials such as GRS and PEO got alert and willingly shared information on payment related issues of MGNREGS.

Human Rights Day Observation:

Human Rights was celebrated at Lohiya Academy on 10th Dec, 2020 at Lohiya Academy, Bhubaneswar, more than 100 participants from different corner of Odisha participated in the program. The participants were Lawyers, Journalists, Human Rights Defenders, Civil Society and others. On that day a human chain was formed in front of Lohiya Academy. The objective was to make people aware of the importance of protecting and promoting human right & values. Followed by this, a discussion session was held on status of human rights and violation taking place in the country.

FREE MOBILE LEGAL AID CLINICS:

One Mobile Legal Aid Camps has been organised to render services to the helpless and marginalised victims with necessary supports and services such as counseling, rescuing victims of HRVs, building confidence, collecting necessary evidences of violations, documenting cases, preparing complaints/writs, helping to register complaints/cases at police stations, N/SHRIs or Courts, linking with experts and organisations for legal aid, trauma counseling, shelter etc. To conduct these sessions pro-bono lawyers and human rights expert has been involved and it has been conducted in Odisha. Adv. Chandranath Dani and Ranjit Sutar have facilitated the Camp.

MONITORING HUMAN RIGHTS VIOLATIONS

Human rights violations in Odisha are being tracked regularly through newspaper, calls from HRDs, Social Media and TV. Each month one news pack is being prepared and shared widely. At need, complaints/memorandums were filed/ sent to appropriate authorities. The violations related land, environment and livelihoods rights in Odisha have been monitored throughout. 23 news items related to Land and Environment rights were shared.

FACT-FINDING VISITS

Fact-finding visits were conducted by skilful HRDs in different parts of Odisha, evidences collected and documented; complaints are registered with the respective authorities in due course of time within the specified period of the project.

Eviction of Sainath Slum in Bhubaneswar:

When the entire country has been asked to stay inside homes amid the COVID-19 pandemic and a nationwide lockdown the twenty four slum dwellers of Sainath Slum, Ward No-9, under Bhubaneswar Municipal Corporation (BMC) Odisha have been reportedly evicted from their native land and rendered homeless due to construct of 200 ft road connecting to Jaydev Vihar -Patia road. The BDA (Bhubaneswar Development Authority), BMC enforcement team with massive police forces including armed troupes on 3rd March, 2021. reached at 9.00A.M at Sainath Slum, in Bhubaneswar to demolish the houses, shops for encroachment free of the Govt land without any notice.

According to RTI Information provided by the PIO, BMC that, No decision has been taken by the Bhubaneswar Metropolitan Corporation to evict the Sainath slum dwellers. Since no decision has been taken by the BMC on the eviction of these slum dwellers, no decision has been taken on their rehabilitation. (In response to the RTI application filed by Deepika Bhatra on January 26, 2021, the information was provided by the BMC North Zone in letter No. 295 dated 23.02.2011, which was received by the petitioner on 20.03.2011.).

Twenty-four families have been completely devastated and living under polythene. Many families' homes have not been demolished, but their electricity connections have been cut off. They have been without electricity for 11 days and are living in the capital. He goes a long way to fetch water. All of these families have been paying electricity bills, regular electricity bills. They were not given any notice, no information before disconnecting their power.



All of these families have lodged complaints with the VSS City Electricity Section Office and Tata Customs Care. They have been provided with a complaint registration number via SMS. But no electricity connection is given or no reason is given. Sainath slum dweller clarification: We have not been notified yet. No financial assistance, land, rehabilitation etc. were given. "It simply came to our notice then. It is learned that the Sainath slum has been demolished to provide parking space for roads and a large welfare pavilion for the apartments of Bana Jena and senior leaders of the ruling party. So provide the full truth first. The Sainath slum is included in the survey under the Prime Minister's Housing Scheme. The list has been published on the BMC website.

Before the eviction drive the administration must ensure the rights of the displaced person and must provide alternative land site for resettlement of families of Sainath Slum and no step should be taken for temporary shelter for evicted families. The practice of forced eviction, when undertaken unlawfully is one of the most egregious human right abuses. It is a practice that it must be prevented

The Universal Declaration of Human Rights (UDHR) states in article 25 that everyone has the right to standard of living adequate for health and well being himself and his family, including food, clothing, housing, medical care and necessary social services and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstance beyond his control.

3. *Fact Finding to Balipatna, Nayagarh*

FELLOWSHIP SUPPORT TO HUMAN RIGHTS DEFENDERS:

Five Human Rights Defenders (HRDs) working for the promotion of rights (related to land, environment, self-governance and livelihoods) of communities has been provided with Fellowship supports to continue their engagements. The selected fellow has been provided with necessary training/orientations after selection. The works completed by the fellow under fellowship period are - Liaise with People's Groups and field W / HRDs, Sharing Information about day today violation news with the team, Assist team in Fact Finding, Organizing Trainings, Meetings and Legal aid Camp, Help and support in documentation, Organize legal aid Camps, Assist in at least in Fact Finding mission. The fellows are operating in four districts of Odisha.

INFORMATION COLLECTION AND DISSEMINATION-UPDATE HRDS AND COMMUNITIES

Information and updates on various schemes, laws, government notices/ announcements and updates relating to the status of their applications already submitted are collected and shared with community members regularly. Responses of duty bearers, authorities, Statutory Human Rights Institutions, Court Orders, best practices in field are gathered and disseminated among HRDs, CSOs, CBOs regularly. Policy related updates, official orders/ notices and documents/reports from various government sources and web-portals were collected. Reports



and documents of other relevant stakeholders related to human rights situation over land, forest, water, environment and linked livelihood situation are collected, analysed and used for community education, advocacy for justice and development. Also, information are collected from news/reports published in various media (print, electronic and digital), social media, different websites, telephonic information collected directly / indirectly from CSOs, CBOs, HRDs and community members.

The relevant and updated Information are circulated through email groups, Social Media regularly and e-newsletters among HRDs, CSO, CBOs and community members. Issues of newsletters across the thematic areas are disseminated.

- A website is functional to provide information online. The viewers of CSNR website has increased. HRDs and associate members of CSFHR are using it to seek information and updates. Resource materials on HR (relevant to Odisha) are being collected and updated regularly in the website. CSNR also decides to improve its website quality and presentation in order to comply Google standards for raising donations through ads.
- Twitter, Instagram and facebook page has also been created by CSNR and is extensively used as a tool to build public opinion in favor of justice to victims and influence the decision makers (policy makers, executives, NHRIs) in a regular manner.
- A monthly news-pack on human rights violations have been developed and circulated among HRDs, different NGOs and others.

- Newspapers and periodicals are being subscribed regularly.
- From time to time resource materials in hard-copy or soft-copy are being collected from different sources and shared among HRDs and Community volunteers.

Through these activities 1000 HRDs, CSOs, CBOs and 50 local communities are kept regularly informed about the ground level reality.

ADVOCACY

ADVOCACY ACTIONS - CASE BASED

Legal Support in defense of Communities rights.

Submission of Applications for Grievance Redressal:

CSNR has pioneered strategies to help communities' access justice and defend their rights through the existing law mechanism. HRDs have been capacitated address grievance redress issues of the communities. They have been empowered to access institutions such as NHRC, OHRC, OCW, NCW.

Complaint Filing: CSNR has filed 80 complaints to statutory institutions such as NHRC, OHRC, WBHRC, OSCPCR, OSCW, NMRC by invoking international mechanisms (In strict adherence to the law of land) like UN treaty bodies, United Nation Human Right Council, EU Bodies, during the year 2020. Out of the 90 complaints filed, 70 complaints have been registered and are currently under trial. The complaints filed includes issues concerning violation of rights related to land, CPF, Livelihood, forceful displacement.

Social Facilitation Centers: 1637 applications were submitted representing the interest of 3920 persons from both the slums who were made aware of their rights related to different schemes and entitlements directly through our activities such as community



meetings, awareness-education-communication materials, trainings, exposure visits. In the meantime, cases of 1320 applications were disposed of, which has benefitted 2516 individuals.

Cases of 1828 helpless and marginalised people who have visited the centers with their problems are being taken up and followed up, which include cases of 110 evicted families (from Farm Gate), cases of 29 eligible school children refused admission by the government schools principals, cases of 30 families who could not get their ration (PDS) due to errors in the Aadhar card and others.

Advocacy for Admission of Neglected Children into Government Schools:

CSNR has facilitated twenty-two cases: Many Children from the slums were denied admission into the government school due to inability to produce Aadhar card properly, which is not a mandatory document to get admitted in the schools. CSNR has taken up these cases as it violates the purpose of the Right to Education Act. After CSNR's intervention 29 Children (28 from Sikharchandi Nagar and 1 from Pandakudia) got admitted to government schools, who were initially refused admission by school authorities for not able to produce Aadhar and such other documents to prove their identity. CSNR approached higher government authorities, National Human Rights Commission, Odisha Commission for the Protection of Child Rights and other authorities.

CSNR also identified 154 dropout students in the two project habitations (Pandakudia and Sikharchandi Nagar) and has written letter to The State Project Director, Odisha School Education Programme Authority (OSEPA) regarding the admission of the drop

out children. After that the Additional Director recommended the District Education Officer-cum-DPC to enquire into the matter and take necessary steps for the admission of the children.

ADVOCACY ACTIONS - ISSUE BASED

Due emphasis has been laid on various advocacy actions with aims to address cases of violation of rights of individuals and communities, to facilitate justice to the affected communities, to influence the duty bearers, authorities for better implementation of existing laws/policies and to facilitate process for changes at policy level keeping in view the just needs of people. In this context a research study has been conducted and 25 media campaigns has been done to improve the current practices, systems and policies towards addressing the issues related to ensure the rights of communities related to forests, lands, water, environment, self-governance, food security, livelihoods as provided under the Constitution of India and Universal Declaration of Human Rights

STUDY AND RESEARCH

- a. Reaching Communities and Human Rights Defenders in Odisha - A Status Report- A study report has been developed by probing the cases of the HRDs through qualitative approach. Through the study report the strengths, weaknesses, threats, opportunities issues, achievements and needs of the people's movements and HRDs working for the movements has been identified. The internal dynamics of movements - reflections, trajectories, relationships, leadership, participation,



conflict management, resource mobilisation were understood. The role and contribution of supporters and allies were understood. A set of recommendations has been developed for movements, civil, society organisations and HRDs. A report has been developed and shared for feedback.

b. ***Studying the Situation of Policing and Crimes in 4-Districts of Odisha:*** A study was conducted in collaboration with Commonwealth Human Rights Initiative covering reported crimes, police personnel, Benefits, complaints against police personnel, accountability. The Report was published and shared widely.

c. ***Baseline Study:*** A base line study has been conducted to assess the present situation of the targeted communities with the purpose to find out the real needs of the community. The types of deprivation of their rights, entitlements and human rights they have to undergo, relevant practical needs of the community, steps taken so far by the community itself to address human rights/governance-related problems have been found out. Available community-based institutions and organisations and their strengths and limitations have been identified. Information was collected from both Primary and Secondary sources. Primary data was collected with help of a structured questionnaire, by interviewing with the key Informants from the slums, 6 numbers of FDGs at different locations in the slums were conducted, data were also

collected through observation and social mapping for both the slum were done. And secondary data were collected from websites, government offices, study reports and others. A database was developed for 2226 households (597 HH in Panadakudia and 1629 HH in Sikharchandi Nagar). The total population covered are 8463 (2140 population in Pandakudia and 6323 population in Sikharchandi Nagar). The study report was prepared and shared in the report sharing workshop.

d. ***Assessment of Functioning of State Human Rights Institutions:*** The Study is underway. Information is being collected through use of RTI.

SOME OTHER ACTIVITIES:

Awareness Activities: 16 types of information on Housing, Sanitation, Aadhar, Pan Card, Birth Certificate, pension schemes, PDS, Midday Meal, Mamata Scheme, ICDS, education have been collected and disseminated. During the project period, 1637 numbers of applications have been filled up and submitted under various schemes and have been processed. 2000 leaflets were distributed among the slum dwellers to create awareness on health issues. Thus, dissemination of information has helped the needy people and enhanced the knowledge of the community on the different schemes and programmes offered by different departments and authorities.

Exposure Visit: Staff along with the community leaders and volunteers had gone for three exposure visits to three model organisations (i)

NREGS Sahayata Kendra, Jharkhand during 7th to 12th January, 2021 and (ii) Jan Vikash, Ahmedabad during 1st to 6th March, 2021 to learn their models, their approaches, the process of intervention in the community, community

centre functioning, leadership building and sustainability. Twenty Community leaders and volunteers and 12 staffs have participated in the above exposure visit programmes and 75% of the participants were women.

NOTABLE ACHIEVEMENTS:

Success Stories:

SFC involvement to settle issues and getting things resolved are extraordinary efforts. Following are the cases where SFC has intervened directly to eliminate difficulties faced by the people.

Srimati's two children could get admission in the school.

Ms. Srimati Digi who is around 30 years old, lives in Jalimunda Sahi slum of Bhubaneswar. She is currently working in BMC as sweeper. She is mother of six children, including herself and her husband there are 9 people in her household. Her husband is also a sweeper at BMC. She is getting Rs 6300/- from BMC as her salary. Total monthly income of the family is Rs 13000/-. She runs her household with this amount, though meager but she manages to address the bare minimum necessity of her family. Earlier she had approached the school to enroll her two daughters, she was refused on the pretext that her children do not have aadhar card. She had met the school authorities repeatedly, but every time she visited, she was returned with the same excuse. She could not summon enough courage to question the school authorities, as she felt that due to lack of authentic identity proof of her and her husband, she may not be able to get aadhar card for her children.

The matter was brought to CSNR's Social Welfare Center. Staff at the center also

tried to convince the school authorities, but there was no result. CSNR then lodged a complaint against the school authorities to the Odisha State Commission for the Rights of the Child (OSCPCR). The chairman then directed the district education officer to review and intervene accordingly. School authorities responded with urgency after the DEO intervened. The school authorities visited slum and requested Ms Srimati, to enroll her children in the school without Aadhaar. Now both her children are studying in the school, the elder one is in 7th class at Nandankanan School and the younger one is at Sikharchandi School in 2nd class.

A widow could get her pension:

Ms. B.Soma has been living in Sikharchandi Nagar slum for last 23 years, now she is 34 years old. She has studied till class 3. She belongs to state of Andhra Pradesh. Soma being a widow lives with her son, daughter and her grandson. Soma works as domestic help and earns Rs 6000/- per month. She stays in a rented house by paying rent of Rs 3000/-. Her husband died seven years ago, since then she has been living in penury and hardship. She is eligible for widow pension, which is Rs 500/- per month. But during the pandemic, she has not received any assistance.

She has approached the concerned officers and had placed her grievance before them. But she was denied on the ground that she does not have aadhar card. During Covid she lost her employment too, as she was not



allowed to enter houses of her employers. Faced with difficult situation, she turned to begging. That was the only alternative left before her to feed her family. State Govt. made a declaration that all the widow pensioner shall receive 3 months of pension in advance. This put her in despair, as her regular entitlement for which she is eligible is in jeopardy.

Soma could get her Adhar after the intervention of CSNR. On 18th Aug, 2020 she could finally get her adhar card. From Sept onward she started getting her monthly widow pension. CSNR has already initiated the process to get her enrolled in food security scheme. She is expected to get her ration card from Bhubaneswar Municipal Corporation shortly.

Srimati got back her lost job due to timely intervention of CSNR:

Srimati Digi, lives in Jalimunda Sahi slum, Bhubaneswar, she is around 30 years old. She is engaged as sweeper in BMC. She is mother of six children. Including herself, she has 9 members in her household. Her husband is also a sweeper in BMC. Previously Srimati was working as a sweeper under RAMKY scheme. She took maternity leave to rejoin her duty after her delivery. But she was not allowed to rejoin, the reason being, a negligible mistake in her adhar number, barred her registered phone to get linked. She had to run from pillar to post and even had to pay bribe to the officials to get her employment regularized.

She approached SFC of CSNR with this problem. SFC took the matter to the concerned department for necessary correction in her adhar card. Consequently the matter got resolved and she joined her duty. She is now getting Rs 6300/- as salary every month.

Child denied schooling for not having birth certificate:

Babita Kahanra, mother of Pihu Kahanra lives in the pandakudia slum of Shampur Bhubaneswar. They are wage earners. After completion of pihu's Anganwadi education Babita tried to admit her in pandakudia primary Govt school. The School authority disallowed her admission on the ground that she was not having Aadhar & birth certificate. As per RTE act 2009, in CHAPTER IV-section 14(2) said No child shall be remain deprived of school education due to lack of age proof. SFC of CSNR, took the onus of putting her back to school. She was admitted in class I, at IRC village Govt. UP school, Nayapali, Bhubaneswar on 24th June 2020. Due to pandemic, schools have not recommenced, but once the school reopens, Pihu can go to her school regularly. The school authorities were convinced by SFC facilitators that with certificate from Aganwadi, Pihu's admission to higher school is conditionally possible, till the UIDAI & Birth certificate are obtained. Due to their ignorance and lack of caution, slum dwellers are often misled by school authorities and even harassed. Sometime the Govt. officials are also unaware of law and statutes.

Study Camps:

During the COVID19 situation with the help of 10 community volunteers (4 from Pandakudia and 6 from Sikharchandi Nagar) CSNR facilitated children's accessibility to education. The volunteers were also conducting awareness session for students and parents. One hundred fifty six most vulnerable children from class 1 to class 10 were able obtain education for three months while they were deprived of online classes as they lacked smart-phones.

Mobile library :

A Mobile Library has been set up with different kinds of books like reference books, story books and others. Children are taking these books from the community organizers and are returning to after reading them. The volunteers and community organizers are taking care of this library as they know all families of their community. The children of different project slums are getting benefit from this library.

LIVELIHOOD PROGRAMMES

Livelihood Training:

During the COVID19 situation with the help of 10 community volunteers (4 from Pandakudia and 6 from Sikharchandi Nagar) CSNR facilitated children's accessibility to education. The volunteers were also conducting awareness session for students and parents. One hundred fifty six most vulnerable children from class 1 to class 10 were able obtain education for three months while they were deprived of online classes as they lacked smart-phones.

Securing livelihood through convergence of IFR and Patta land:

During Covid-19, running household through existing income got more difficulty. This has urged CSNR to undertake livelihood promotional activities in IFR and revenue land. The initiative helped the communities in mitigating immediate food need as well as could help them earn during the time when no other income generating source was available. In 7 districts (Bargarh, Balangiri, Ganjam, Gajapati, Sundargarh and Mayurbhanj) 474 acres of land was utilized for agriculture & horticulture purpose which has benefitted 390 households.

Mo Upakari Bagicha-(My Beneficial Garden)

The Government of Odisha, Department of Panchayati Raj & Drinking Water with Odisha Livelihoods Mission (OLM) has launched a state-sponsored programme 'Mo Upakari Bagicha' (My Beneficial Garden) in a bid to mitigate long-term nutritional inadequacies caused by the Covid-19 pandemic and also to reverse migration. It schemes aims to encourage women to grow vegetables and fruits at a minimal cost in the backyards to get fresh vegetables to meet family need and sell the

surplus in the market to earn a living. The State Government has emphasized on creation of nutri-gardens in 750 panchayats to mitigate the adverse impact of the lockdown.

The scheme provided support of Rs. 10000/- (Rupees ten thousands) to the selected beneficiaries. The scheme have been implemented successfully in Rayagada, Baragarh, Malkanagiri, Gajapati, and Ganjam districts by CSNR's facilitators. Under Covid19 special program, 431 households of 38 villages of Paikamal (20) and Jharbandh (18) Blocks were provided financial support of Rs 18000/- per family for vegetable cultivation under this scheme.

With facilitation support of JJAS, Baragarh in Khaprakhol Block, Balangir District 381 families of migrant workers, two persons per family were provided jobs for 3 months (April-June) under MGNREGA for digging pond, canal, land leveling, construction of pucca houses, Mo Bagicha (My Garden) and plantation works. Other convergence works under taken in forestland also supported the livelihood initiative of the villagers.

**Land to Landless and Homestead land less Families:**

613 landless and homestead less families were identified in Daiselet, Padmpur, Paikamal and Jharbandh tehsil through CSNR intervention and support of JJAS. 261 families have got homestead land, 181 possess the receipt of paying fine to revenue department for occupying the land, as evidence. Revenue department is not showing any inclination to provide them record of rights. Application for 463 homestead land less family have been submitted to Tehsildar of Bhutan tehsil of Dhenkanal for record of rights.

ORGANISATIONAL LEVEL UPDATE:

-One of the staff took a three days virtual training on Social Impact Measurement and Management: Theory, Concepts and Practical Tools imparted by CSRBOX India.

-Two of the staff took a virtual training on Minority and Human Rights conducted by Minority rights Group International (London).

INTERNS:

Interns are an integral part of our organization and we greatly value their efforts and contributions towards our work. Our interns go back with the commitment to contribute to society through the experience they have gained while working with us. CSNR provides internship programme to those students from Universities committed to human rights in India. The interns are provided guidance and theoretical training along with wider field exposure to enhance their knowledge and understanding on different dimensions of rights and justice. In 2020-21, 33 students from 11 states of India have undergone internship on Human Rights.

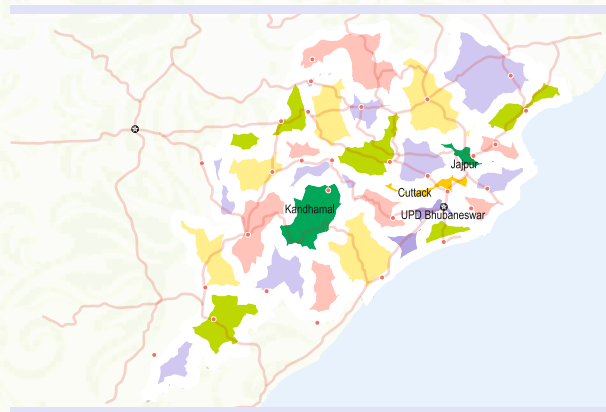
PUBLICATIONS

CSNR and Commonwealth Human Rights Initiatives (CHRI) has undertaken a study on state of crime and policing in Odisha with the aim of evaluating police capacity against the volume of crime. The study was completed within six months time period. The study had focused on the capital city of Bhubaneswar, Urban Police District Cuttack, Police District Kandhamal and Police District Bhubaneswar (4 Districts) as a sample Districts. It has documented registered crimes, police vacancies and complaints against the police across all police stations in these 4 districts of Odisha. Data has been gathered through RTI.

COMMUNICATION AND INFORMATION SHARING

CSNR/ CSFHR has developed an E-group namely 'odishahrd', a Facebook Page (Civil Society Forum on Human Rights - CSFHR/ <https://www.facebook.com/cschr?fref=ts>) and a web portal (www.cschr.com) to create a resource pool on Human Rights and to help the Human Rights Defenders with update and real time information. In addition to these, CSNR has also initiated the regular circulations of News Pack and E-Newsletter. Resource materials such as news items, articles, special stories published on Human Rights (relevant to Odisha) are being collected and circulated regularly with the CSOs, HRDs and others significant through email.

The development and publication of monthly E-Newsletter, which started in November 2014, is a noble effort to share information and experiences of the HRDs related to human rights movement in Odisha. It comprises of the activities and events of CSNR, news related to human rights violation cases, recent orders and judgments by the Supreme

Court of India, the Odisha High Court, important actions taken by Human Rights Institutions and the success stories of Human Rights Defenders.

Apart from this, the activists associated with CSNR/ CSFHR are involved in a regular process of dissemination of information from daily newspapers on human rights violations and circulating the same among the civil societies through Social Media, Mobile Calls, SMS, Whats App etc. for their knowledge and further action.

NEWS PAPER PUBLICATION

- a. Fourteen numbers of media campaigns to highlight the issues of slum-dwellers have been taken up with the help of media experts through writing of columns in newspapers, news/reports in social media and telecast through TV channels. These campaigns helped to attract the attention of authorities, political parties and statutory human rights institutions.
- b. News items and reports are released through social media after the HRD intervention.
